PRELIMINARY NOTIFICATION

(Issued under sub-section (1) of section (7) of the Arunachal Pradesh Urban & Country Planning Act, 2007) Act No. 3 of 2008.

Whereas the Government of Arunachal Pradesh under the provisions of sub-section (2) of section (1) of the Arunachal Pradesh Urban and Country Planning Act, 2007 (Act No. 3 of 2008), has extended the said Act to Namsai District Headquarter, vide notification No.DTP/Estt-55/2008-09/80-217 dated 3rd June 2008;

AND WHEREAS, in exercise of the powers conferred under section 9 (1) & (3) of the Arunachal Pradesh Urban & Country Planning Act, 2007, the state government has constituted the Namsai Planning Authority vide notification No.DTP/Estt-48/2007-08/4480-99 dated 13th March 2012;

AND WHEREAS, the Namsai Planning Authority has intended to prepare the Interim Development Plan for Namsai Township (Headquarters) under the provisions of sub-section (1) & (2) of the section (18) of Arunachal Pradesh Urban & Country Planning Act, 2007, Act No.3 of 2008;

AND WHREAS, Namsai Planning Authority is intended to declared the Local Planning Area(s) under the provision of sub-section (1) of section (7) of the Arunachal Pradesh Urban & Country Planning Act, 2007 (Act No. 3 of 2008), a board meeting was held on 15th October 2015 at Office Chamber of Deputy Commissioner, Namsai in this regard and a committee have been constituted for demarcation of the boundary limit. The department of Town Planning & ULB's has conducted the survey in consultation with Land Management & Urban Development & Housing for proposed Local Planning Area Boundary w.e.f. 15th October 2015 to 25th October 2015 and the same has been re-verified on 29th & 30th January 2018.

AND WHEREAS, in exercise of powers conferred under sub-section (1) & (2) of section (7) of the Arunachal Pradesh Urban & Country Planning Act, 2007 (Act No. 3 of 2008), the Governor of Arunachal Pradesh is pleased to notify, with immediate effect, of the following areas, localities of Namsai, and other areas indicated in Schedule-I to be Local Planning Area for the purpose of said Act, which shall be called by the name of Namsai Planning Area and boundary of the said area is indicated in Schedule – II below.:-

SCHEDULE-II Statement Showing the detail Boundary Description of Namsai Planning Areas/Region

DIRECTION	DESCRIPTION NAMSAI PLANNING AREA
North:-	The North boundary of the Namsai Planning area start from the Dharampur bridge over Deobeel Nallah (Old Dihing Road) of which mark point is (MP020) where Northing 27°40'27'' & Easting 95°49'59'' then, moving northeast ward direction and joined the Jenthu Nallah, after 300 meters traverse along Jenthu Nallah boundary straightly push from confluence of Jenthu-Jaipur Nallah i.e (MP022) N27°41'6'' & E95°50'14'' towards the farmland of Kasik Village and connected to the farm-road. Then boundary traverse along Kasik village road till it meet the tri-junction of Namsai-Jaipur Road.
	Then boundary turns left from tri-junction [N27°42'529" & E95°51'473" and traverse along Jaipur-Namsai Road and turn right from another tri-junction at Jaipur-Solungtoo Road then traversing along Jaipur-Solungtoo road till it meet the NH52 at Solungtoo Village.
East:-	Eastern boundary start from the point where north boundary ended as Solungtoo-Jaipur and NH52 tri-junction [which also marked (MP253) N27°43'779" & E95° 54' 495"]. Then boundary traverse westward along the NH52 till it meet another tri-junction at Kungyao Village [MP N27°42'286" & E95°53'905". Then boundary turns left from the tri-junction point and moving along the rural road and join to the Noifai seasonal Nallah or irrigation cana (MP254) N27°42'212" & E95°54'060" then continuously moving up to bridge over nallah at Lathao- Manfaiseng road on Manfaiseng Village [MP254 N27°42'517" & E95°55'356". Then boundary turns right and following the Lathao-Kaisu road till it meet the Manmow-Lekang Khamti road in front of the Kaisu village temple [MP N27°40'212" & E95°54'952"]. Then boundary turn left from the tri-junction point and traverse along the road and hovering the Mengkeng, Lekang Khamti, Pengen and ends at Wingko Tri-junction [MP N27°37'794" & E95°57'076"]
South:-	The southern boundary start from ending point of east boundary at tri-junction of Wingko village and moves southward direction continuously traverse till if find the Piyong Khamti (Tri-junction) where its coordinates are (MP-035 N27°35'23.86" & N95°56'16.35". Then boundary turns left along the Namsai Diyun road till another tri-junction at Piyong Singphoo (Tri-junction) road where its coordinates are intersecting (MP264) N27°35'0.165" & E95°56'31.1".
	Then boundary turns right from the tri-junction point along the Phange village road and boundary run straightly up to the bank of Dihing Ri (boundary has been straightly connected to Dihing River at (MP2 N27°34'.680'' & E95°55'.041'' and ended.

	The western boundary start from the ending point of south boundary at bank of
West:-	Dihing River i.e. (MP267) N27°34′.680″ & E95°55′.041″. The Mark Point has been taken at the bank of Dihing River. Then moving northward continuously following the Dihing River by hovering the various localities like-Nampong, Ningroo Charali, Philobari, Adi Ningroo, Kungseng, Kungsung, Deobeel village, Namsai Town and joined the starting point of the north boundary at Dharampur bridge over Deobeel Nallah that connecting Deobeel Nallah & Jenthu Nallah on (MP020) N27°40′27″ & E95°49′59″.

*Note- If any Localities/Settlements which comes within Namsai Planning Area/Region boundary name is missing in Schedule-I and same village name is listed at census 2011 then it shall include automatically under the Namsai Planning Area/Region.
